Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Harris County, Texas, said address being an office and meeting place of the District.

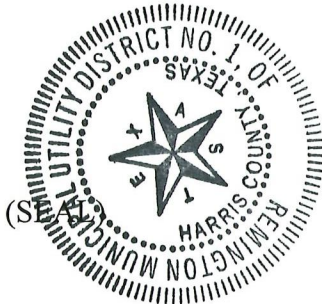
**The meeting will be held on Wednesday, October 23, 2019, at 12:00 p.m.**

The Board will consider and discuss the following matters and take any action appropriate or necessary with respect to such matters:

1. Public comments;
2. Review and approve the minutes of the August 28, 2019, and September 25, 2019, Board of Directors meetings;
3. Report on security patrol;
4. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented, approving tax refunds, and approve moving of accounts to uncollectible roll; consider approval of Account Access and Authorization Agreement for enrollment in Positive Pay program;
5. Report and legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
6. Engineer's Report, including:
  - (a) Authorize the design and/or solicitation or advertisement for bids for the construction of facilities within the District;
  - (b) Authorize the award of construction contracts for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, as applicable, including:
    - (i) Wastewater Treatment Plant Improvements;
  - (c) Status of construction of facilities to serve land within the District, including the approval of any change orders, and authorize acceptance of TEC Form 1295, as applicable, including:
    - (i) Fourth blower at Wastewater Treatment Plant;
  - (d) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes; and

- (e) Issuance of utility commitments;
7. Report from Champions Hydro-Lawn, Inc. regarding repairs and maintenance of ponds and ditches, status of renewal of storm water quality permits, and consider proposals for repairs and acceptance of any related TEC Form 1295s, including:
    - (a) Status of repairing storm drain sinkholes located at the Section 11 Detention Basin;
  8. Operator's Report, including:
    - (a) Appeals of District charges and customer complaints and status of collections of the District's delinquent water and sewer accounts and approve write-off or referral to collections of uncollectible accounts;
    - (b) Compliance with permits and regulatory requirements, including discussion of any violations of same and review of notices of violations, self-reporting of any violations as required, and responses from regulatory agencies;
    - (c) Status of repair of Booster Pump No. 4 at Water Plant No. 2;
    - (d) Review of available dates to schedule tour of District facilities; and
    - (e) Investigation into request by District resident for treatment of storm sewers in Crimson Canyon for cockroach problem;
  9. Bookkeeper's report;
    - (a) Distribution of monetary reclaimed water credits from the WHCRWA to Sterling Golf, Inc. pursuant to Settlement Agreement with Sterling Golf, Inc.; and
    - (b) Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting and authorize any action in connection therewith;
  10. Annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution and amended Order in connection therewith;
  11. Status of District website; authorize any action necessary or appropriate in connection therewith;
  12. Presentation of EVO Program Report from Municipal Financial Services;

    - (a) Request for joint meeting with S-G Owners Association, Inc. in the District;
